#### PAST PRESIDENT'S LETTER

Dear ASMB Member:

It has been an honor to serve you as President of our Society during the 2003 calendar year. Three hundred and sixty-five days pass rather quickly, so not unexpectedly, lofty goals have been only partially met. Checco Ramirez, with an extra day in 2004, should be able to do better. Nevertheless, I think that progress has been made on several fronts. Much of my effort during the past year was devoted to preparation for our Second National Meeting that will be held in November of this year. Our Program Committee, under the leadership of Mark Ginsberg, has assembled an excellent program. Preparations for the meeting have been ably accomplished by our Organizing Committee, headed by cochairs Vito Quaranta and Jim Quigley. They have chosen an exciting venue, the Grand Hyatt Hotel, which is adjacent to the Convention Center in San Diego. We are also fortunate to have the services of an excellent convention service, Scientific Associates Management, headquartered in Santa Fe and directed by Judith Sjoberg. I therefore think that we can look forward to an exciting meeting that will rival our highly successful first meeting in 2002. Please consult our website (www.asmb.net) for details of the meeting. You may also register and submit an abstract for the meeting online.

We have received a very good priority score for our application to the NIH for partial support of our meeting, and we are optimistic that the application will be funded. In addition, our application for partial funding to the Shriner's Hospital in Portland, Oregon has been approved. However, as is common with meetings of this size, the majority of the funding will come from registration fees. We therefore look forward to a strong showing on the part of our members, as well as non-members who wish to familiarize themselves with exciting new developments in diverse

areas of matrix biology. This meeting will be a chance to meet old friends and colleagues, as well as to make new ones, and it provides an unparalleled opportunity to gain an appreciation for the complex interactions between matrix biology and a host of other clinical and basic science disciplines.

I also wish to call attention to the fact that our Society will be a guest of the American Society for Investigative Pathology at EB 2004 in April of this year, a meeting to be held in Washington, D.C. We are co-sponsors of two symposia on the molecular and cellular basis of disease relating to the extracellular matrix, and I hope to see many of you there.

One of the many challenges for a Society of our current size is to increase its membership to a level that is able to support an effective infrastructure. The Society continues to grow slowly. It is approaching a total of 700 members, not all of whom have paid their dues for the current year, but we need an even larger Society. At our meeting in December of last year, our Council discussed ways in which membership growth could be achieved. Clearly, recruitment of new members by existing members is an effective way to expand our Society. I would therefore hope that those of you who have colleagues

who are likely to be interested in ASMB would extend an invitation to them to join. One can easily sign up online at our Web site.

Our reasons for seeking an increase in the membership of our Society are several. As stated in the brochure for our upcoming meeting, Matrix Biology is positioned at the nexus of a number of scientific disciplines, including cellular and molecular biology and other basic sciences, bioengineering, and a variety of clinical disciplines including orthopedics, dermatology, rheumatology, and tumor biology. The sharing of information and ideas among these various disciplines is almost certain to result in exciting new directions in our research. A more practical consideration is that the administration of our Society is in need of better continuity. The transfer of administrative responsibility on a yearly basis, as new Presidents assume the responsibilities of their offices, is inefficient and is prone to lapses in our ability to provide adequately for the needs of our membership. Our ability to hire an Executive Director, even if it is initially a joint appointment with one or two other Societies, would provide much needed continuity and reliability in administrative functions. However, the only reliable source of funds for our Society is membership dues, and a larger membership base is needed if dues are to be maintained at a reasonable level.

I am confident that these needs will be met in the near future, and I know that I leave the Society in good hands as Checco Ramirez assumes the Presidency in 2004, and Linda Sandell becomes President in 2005.
